We are asking local artists to create original works which utilize the event's theme, An Evening in Paris, and reflect the organization's mission statement of "engaging and encouraging the women in our community to become involved as philanthropists, as advocates and as mentors."

Artwork entered in the competition will be judged by a volunteer panel to include local artists, FLiP members and members of the United Way Board of Directors.

*The winning artwork will be revealed at the FLiP Signature Event, An Evening in Paris, on July 29<sup>th</sup> at the Tower Club.*

*The winning artwork will be permanently displayed at the FLiP Suit Yourself Boutique.*

*Limited edition prints of the winning artwork will be sold to the public with proceeds benefitting FLiP.*

*Annual FLiP acknowledgement cards will carry a reproduction of the winning artwork and be distributed to patrons who make individual donations to FLiP.*

All entries in the competition, with the exception of the winning artwork, will be sold during the live or silent auction portion of An Evening in Paris.

## *Competition Rules*



Entries must be family-friendly.

Artists must submit entries to United Way of the Ozarks (320 N. Jefferson) by **noon** on Friday, July 13, 2012.

The first 10 artists entering the competition will receive 2 complimentary tickets to An Evening in Paris.

Original paintings will be accepted in any medium provided that they are in a suitable condition to hang when submitted. Minimum size requirement of 11" x 14".

Artists must grant United Way of the Ozarks the right to reproduce their entry for publicity and other purposes.

Artists must complete commitment/release form to United Way of the Ozarks at the time of submission.
